Dear Friends,

No matter what trials and tribulations we face, there is hope to encourage us and get us through.

As faithful people, we know a deeper source of trust and hope. We are reminded that God will give us the strength to weather any storm, to face our trials and tribulations, to keep moving forward toward brighter days ahead. "Hope" is the thing with feathers -That perches in the soul -And sings the tune without the words -And never stops - at all -

And sweetest - in the Gale - is heard -And sore must be the storm -That could abash the little Bird That kept so many warm -



Hnatiuk Family Update

The Hnatiuk family marked two years on the Luchterhand farm on January 30. After arriving in 2023, Olesia and Mykola found jobs, worked on improving their English, and settled into their new way of life. The immigration service gave them 2 years of Humanitarian parole which could be extended by applying for another 2 years under a re-parole program offered by the Biden administration. Olesia mailed all 4 applications together, but only hers was processed and approved. She had to reapply for Mykola and the boys. Mykola's work authorization expired on January 28, 2025 because his paperwork was delayed due to a clerical error. He could not work as he waited for a new authorization period. One week ago he received his renewed authorization just as the new administration paused all processing. He can now work until October 19, 2026 if their temporary protective status is not canceled as has happened to other immigrants.

Mykola is currently looking for a new job. Olesia continues as an exemplary student at Midstate Technical College taking credits toward a nursing degree. She works as a daycare teacher at Zion Lutheran Early Childhood Center in Colby and as a nursing assistant at Clark County Rehabilitation and Living Center while taking classes. It is a very stressful time for them, but the family continues to make their life as normal as possible for their two boys ages 8 and 4. The boys enjoy swimming at the YMCA in Marshfield and Roman has a wrestling class at his school twice a week. He speaks English very well, but has some difficulty in school understanding all the lessons. For instance he is good in math, but has trouble with story problems. Dmytro is in 4 year old Kindergarten two days a week. When asked what he would like to do for his birthday in April, he responded he wants to go fishing, That was his favorite activity last summer along with racing around the farm (he loves to run), jumping on the trampoline, and picking raspberries and apples. Mykola has bees for honey, but Roman loves maple syrup which he never had before coming to Wisconsin. The family is looking forward to helping in the Luchterhand sugarbush this spring.
